Council reserves the full rights to negotiate further terms, conditions and requirements of the quotation with the successful bidder. Council has full rights to terminate the contract should they deemed fit to do so.

This quotation will be subject to the Preferential Procurement Policy Framework Act, Preferential Procurement Regulations of 2011 as the bidder who scored the highest points on price and preference points will be appointed. Polokwane Municipality shall adjudicate and award quotation in accordance with B-BBEE Status Level of Contribution or sworn B-BBEE affidavit on an 80/20-point system, 80 points will be allocated for price and 20 points will be allocated for B-BBEE level status. Quotation will remain valid for a period of ninety (90) days.

General Conditions of the Contract (GCC) and, if applicable, any other special conditions of the contract will apply and any deviation from these conditions by the bidders will render their bid non-responsive and thus will be disqualified.

N.B: No quotation will be considered from persons in the service of the State(as defined in Regulation 1 of the Local Government: Municipal Supply Chain Management Regulations).
